

**PASSENGER AUTHORIZATION AND RELEASES OF LIABILITY**  
(Both Passenger and Driver Should Read Carefully Before Electing to Voluntarily Sign)

**I. PASSENGER AUTHORIZATION**

This document constitutes authority by TRX, INC ("TRX") for \_\_\_\_\_ ("Passenger") to be transported as the only passenger on Unit # / Contractor # \_\_\_\_\_/\_\_\_\_\_ with \_\_\_\_\_ ("Contractor") as the only driver of the tractor. Passenger authorization shall only be from \_\_\_\_\_ ("Origin") to \_\_\_\_\_ ("Destination"), with the authorized transportation beginning on \_\_\_\_\_, 200\_\_, and ending on the date when the Destination is reached. This authorization shall not include any deviations or detours for personal reasons. Passenger is not authorized to operate the unit or associated trailer (collectively "Equipment") or to perform any labor associated with the Equipment or load at any time.

By signing below, Passenger acknowledges and agrees that Passenger is not an employee of TRX or an independent contractor providing goods or services to TRX. Passenger further acknowledges and understands that TRX will not pay any amount for any accident, injury, loss or damage arising out of or related to Passenger riding in the Equipment and that TRX will not provide a policy of insurance that provides coverage, including workers' compensation coverage, for Passenger or Passenger's property.

**II. RELEASES OF LIABILITY**

**A. Contractor's Full Release of Liability.** In consideration for TRX's authorization to allow Contractor's spouse, son, daughter, or any other passenger to ride in the Equipment, Contractor, by signing below, hereby releases TRX from any and all claims, liability, rights, actions, suits and demands, including any rights under a claim of loss of affection or of consortium, whether in law or in equity, that Contractor may have against TRX, including its affiliates, employees, agents, officers, directors or successors. Moreover, this signed Release may be pleaded by TRX as a counterclaim to or as a defense in bar or abatement of any action of any kind whatsoever brought, instituted, or taken by or on behalf of Contractor. Contractor confirms that he/she currently maintains passenger insurance coverage as required by its independent contractor operating agreement with TRX. Contractor also agrees that this Release shall be governed by the laws of Minnesota.

**B. Passenger's, Parent's or Guardian's Full Release of Liability.** In consideration for TRX's authorization to allow Passenger to ride in the Equipment, Passenger, or Passenger's parent or guardian if Passenger is under the age of 18 years, by signing below, hereby releases TRX, with respect to the authorized transportation, from any and all claims, liability, rights, actions, suits and demands, including any rights under a claim of loss of affection or of consortium, whether in law or in equity, that Passenger may have against TRX, including its affiliates, employees, agents, officers, directors or successors. Moreover, this signed Release may be pleaded by TRX as a counterclaim to or as a defense in bar or abatement of any action of any kind whatsoever brought, instituted, or taken by or on behalf of Passenger. Passenger also agrees that this Release shall be governed by the laws of Minnesota.
